

CAPITAL ASPHALT'S TERMS & CONDITIONS

Capital Asphalt will provide the customer with snow blowing services as an independent contractor in accordance with the following terms, conditions and limitations:

The contract is for the 2021-2022 winter season commencing on November 1, 2022 to April 15, 2022.

The contractor will be responsible for removing any snowfalls from the customers driveway that has an accumulation of more than 5cm (2 inches), any snowfall less than 5cm (2 inches) is the responsibility of the customer to clean their driveway unless the company has agreed to come for a curtesy cleaning.

Snow blowing will not start until 5cm or more of snow has fallen. If the forecast calls for only 5- 10cms of snow, more than one pass will be completed. The contractor will return for plow-ins and final clean-up from each snow fall.

Capital Asphalt ensures cleaning the laneway at all hours of the day and night. Exact times of clearing cannot be guaranteed as we can never tell when the snow will begin. If you cannot get out of your laneway or have an emergency, we can dispatch a driver to assist you. We always do our best to have all laneways cleared early in the morning and again in the afternoon.

Capital Asphalt promises to be available to you 7 days a week including all holidays such as Christmas and New Year's. When the snowfalls we are available.

This contract covers a total accumulation of 275cms (9 feet) of snow which will be kept track of on our log sheets found on the website. If the seasonal snowfall exceeds 275cms the customer agrees to pay a surcharge which will be calculated by the amount of extra snow received, the number of extra visits required, and the original contracted price. **(Example: Driveway Snow blowing: $\$400 \div 275\text{cms} = \$1.45/\text{cm}$ multiplied by 50 additional cms = $\$72.50$)**

The customer understands and agrees that it is their responsibility not to leave any movable objects such as garbage cans, extensions cords, down spouts, basketball nets, toys, etc. in the area where the snow blowing service is to be performed. If items are to be left in the way affecting the work to be performed your driveway could result in being missed until movable objects are moved. Water valve caps in the driveway that are elevated need to be hammered down, so they are flush with the flat surface. This is the customer's responsibility or the town of Arnprior can be contacted @613-623-4231. The contractor will not be held responsible for any damages done to moveable objects. If damages occur, they must be reported within 14 days of the snow incident.

The contractor shall not be held responsible for any damages arising from scraping, scratching or rusting of the driveways, nor is the contractor responsible for any salt damage to the customer's lawn.

In the event that vehicles are parked in the driveway the contractor will only remove snow from the accessible areas opening on to the street and only return to clean up where the car was parked if a complete second pass is planned.

If the customer is receiving walkway shoveling, it will be completed once within 12 hours of the snowfall being completed. This service does not include snow removal caused from drifting/blowing snow, roof cleaning or ice build-up from freezing rain.

The contractor will supply and install a minimum of 2 black & yellow markers on each side of the driveway. **If the markers are damaged by the customer or the contractor, it is the responsibility of the customer to fix the marker or notify the contractor for repair or replacement.**

There will be a \$25.00 administrative fee charged to the customer on all cheques returned for any reason.

The contractor is fully insured for public liability and property damage insurance. All employees of Capital Asphalt are covered under the Workplace Safety and Insurance Board.
